



**OFFICIAL MEMBERSHIP AGREEMENT

This Agreement is made between Jason Morris Judo Center and _____
(Member, Parent/Guardian) for _____.

Member has applied for the privilege of using the services and facilities of the Center including receiving education, instruction and training in the Sport of Judo. Member has represented to the Center that he/she is fit and qualified to use the services and facilities of the Center and accepts the responsibility of Center Membership subject to the terms and conditions set forth below:

1. Member acknowledges the Membership Dues and Member agrees to make full and timely payment of the balance.

Payment Schedule can be arranged individually.

2. Member agrees to abide by all rules and regulations currently in effect or which may be changed or promulgated from time to time be the instruction staff relating to the operation and use of Center facilities and services.

3. Member represents and agrees that he/she is in good physical condition and able to use the equipment, facilities and services provided and, to take the exercise recommended; that Member will use the equipment, facilities and services and take such advice at Member's own risk; that Member further agrees and acknowledges that the Center, it's agents, representatives or assigns shall not be liable to Member, or anyone claiming through or on behalf of Member, for any injury sustained or received by Member as the result of the participation in or use by member of the equipment, facilities, services, or instruction of the club.

4. Member agrees to join (if not already a member) and remain an active member during the term of this Agreement of the United States Judo Inc. (USJI) or any entity or Governing body that succeeds the USJI as the National Governing Body. Membership in the USJI is a condition precedent to Center membership.

5. Member cannot cancel this Agreement or assign this Agreement, his Membership or privileges to any other person. Member's failure to use the facilities, services or instruction of the Center shall not relieve Member from the obligation to make full payment of the prescribed Membership fee.

6. Center hereby grants to Member all rights and privileges of Membership in the Center for the period extending from the enrollment date to the expiration date set forth herein.

7. Each of the agreements and representations of Member is a material inducement for Center to enter into this Agreement, and Center may terminate this Agreement and the

Membership if any of Member's Agreements are not fulfilled or Member's representations are not correct. The use of any equipment, facility or service of the Center may be curtailed or denied whenever the instructor, in his discretion, believes such use might be detrimental to the Member's health or well being.

8. I the undersigned fully understand that Judo is a contact sport wherein there is a possibility of serious injury or death and, in consideration of my acceptance of this Official Membership agreement from the date of its execution until the date of its expiration, I for myself, my heirs, executors, administrators, and assigns do hereby release and discharge Jason Morris, Teri Takemori, Jason Morris Judo Center, US Judo Inc, NYJI, United States Judo Federation their officers, employees, agents, or representatives of and from any and all claims or demands, losses, or injuries incurred or sustained by me or my minor as a result of attending, participating in, practicing for, or traveling to and from activities involved or arising from The Jason Morris Judo Center. Further, I agree to accept any and all financial obligations incurred as a result of my participation in the sport of Judo inclusion but not limited to any medical assistance, hospitalization, and related expenses, which may arise out of my participation, attendance, practicing, or traveling from or because of this Judo Center. If a minor, this Agreement shall be signed by the parent of said minor and shall have full force and effect on behalf of said minor, said minor's family, said minor's heirs, or estates for any injuries or damages which may be sustained by said child.
