

Warning! Waiver and Release of Liability and Agreement to Participate



In consideration of being permitted to participate in any way, including travel to and from, in any judo tournament, practice, clinic and related events and activities of the United States Judo Inc., United States Judo Federation, United States Judo Association, New York State Judo Inc, Jason Morris Judo Center, Inc., I hereby:

- 1. Acknowledge that I am familiar with the sport of judo and understand the rules governing the sport of judo.
- 2. Agree that prior to participation, I will inspect the mats, equipment facilities, competition pools or divisions and the elimination or scoring system to be used and if I believe anything is unsafe or beyond my capability, I will immediately advise my coach or supervisor of such condition(s) and refuse to participate.
- 3. Acknowledge and fully understand that I will be engaging in a contact sport that might result in a serious injury, including permanent disability or death, and severe social and economic losses due to not only my action, inaction or negligence of others, the rules of the sport of judo, or the conditions of the premises or any equipment used. Further, I acknowledge that there may be other risks not known to me or not reasonably foreseeable at this time.
- 4. Knowing the risks involved in the sport of judo, I assume that risk and accept personal responsibility for the damage following such injury, permanent disability or death.
- 5. Release, waiver and discharge and covenant not to sue the United States Judo Inc., United States Judo Federation, United States Judo Association, New York Judo Inc., Jason Morris Judo Center, their affiliated clubs, their respective administrators, directors, agents, coaches and other employees or volunteers of the organization, event officials, medical personnel, Jason Morris, Teri Takemori, other participants, guardian(s), supervisors and coaches, sponsoring agencies, sponsors, advertisers, and if applicable, owners, lessors, and lessees of the premises used to conduct the event, all of whom are hereinafter referred to as "releases," from any and all claims, demands, losses, or damage on account of injury, including permanent disability and death or damage to property, caused or alleged to be caused in whole or in part by the negligence of the releasee or otherwise to the fullest extent permitted by law.

I HAVE READ THE ABOVE WARNING, WAIVER AND RELEASE, UNDERSTAND THAT I GIVE UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND KNOWING THIS, SIGN IT VOLUNTARILY. I AGREE TO PARTICIPATE KNOWING THE RISKS AND CONDITIONS INVOLVED AND DO SO ENTIRELY ON MY OWN FREE WILL. I AFFIRM THAT IAM AT LEAST 18 YEARS OF AGE, OR, IF I AM UNDER 18 YEARS OF AGE, I HAVE OBTAINED THE REQUIRED CONSENT OF MY PARENTS/GUARDIAN AS EVIDENCED BY THEIR SIGNATURE BELOW.
