COMPETITOR CHECK-IN AND TOURNAMENT START:

ALL COMPETITORS must check in by **4pm** Saturday at the tournament site: BHBL High School.

Tournament starts at **5pm** Saturday.

KATA DIVISIONS:

Nage-No-Kata

Katame-No-Kata

Ju-No-Kata

TEAM MAKE-UP:

Same Gender Teams and Mixed Gender Teams will compete in the same kata divisions.

ELIGIBILITY:

Current USJI, USJA, USJF, ATJA, Foreign National membership. *Copies of current membership for Tori and Uke must be sent with application or presented at registration to be eligible to compete.*

REQUIRED FORMS – all to be presented at REGISTRATION:

- A Kata competition entry form for each team for EACH kata division entered.
- A signed competition waiver for each competitor.
- Competitors under age 18: A parent or legal guardian must sign the competition waiver.

AWARDS:

- 1st, 2nd, and 3rd Place medals will be awarded to the teams in each Kata division.

JUDOGI:

White judogi in regulation size are mandatory for Tori and Uke

COMPETING IN MULTIPLE KATA DIVISIONS:

The **same team** may compete in all **(3) katas** (Uke and Tori may switch roles).

Separate entry forms must be completed for each kata entered.

ENTRY FEES:

\$75 per team (Paid by October 11), \$35 per team for second kata, \$25 per team for third kata.

\$85 WALK-INS day of registration, \$45 for second kata, \$35 for third kata. (must be the same pair).

PAYMENT:

All entry fees must be in **US Currency/US Funds**

- Postal Money Orders and Certified Bank Checks must be in **US FUNDS**

In consideration of being permitted to participate in any way, including travel to and from, in any Judo tournament, practice, clinic, and related events and activities ("Activity") of the **United States Judo Federation, Inc., USA Judo/United States Judo, Inc., United States Judo Association, Inc., American Traditional Jujutsu Association, Hudson Yudanshakai, New York State Judo, Inc., Burnt Hills-Ballston Lake CSD, Jason Morris Judo Center, any Medical & Emergency Services Company and individuals**, I agree:

1. I understand the nature of Judo activities and believe I am qualified to participate in such Activity. I also understand the rules governing the sport of Judo.
2. I further acknowledge that prior to participating, I will inspect the mats, equipment, facilities, competition pools or divisions, and the elimination or scoring system to be used, and if I believe anything is unsafe or beyond my capability, I will immediately advise my coach, supervisor, and/or a tournament official of such conditions and refuse to participate.
3. I acknowledge and fully understand that I will be engaging in a contact sport that might result in serious injury, illness or disease, including permanent disability or death, and severe social and economic losses due not only to my own actions, inactions or negligence, but also to the actions, inactions, or negligence of others, the rules of the sport of Judo, or conditions of the premises or of any equipment used. Further, I acknowledge that there may be other risks not known to me or not reasonably foreseeable at this time.
4. Knowing the risks involved in the sport of Judo, I assume all such risks and accept personal responsibility for the damages following such injury, illness, disease, permanent disability, or death.
5. I hereby release, waive, discharge and covenant not to sue the **United States Judo Federation, Inc., USA Judo/United States Judo, Inc., United States Judo Association, Inc., American Traditional Jujutsu Association, Hudson Yudanshakai, New York State Judo, Inc., Burnt Hills-Ballston Lake CSD, Jason Morris Judo Center, any Medical & Emergency Services Company and individuals**, together with their affiliated clubs, their respective administrators, directors, officers, agents, coaches, and other employees or volunteers of the organization, event officials, medical personnel, other participants, their parents, legal guardians, supervisors and coaches, sponsoring agencies, sponsors, advertisers, and if applicable, owners, lessors, and lessees of premises used in conducting the event, all of whom are hereinafter referred to as "Releasees", from any and all litigation expenses, attorney fees, loss, liability, damage or costs on account of injury, illness, disease, including permanent disability and death or damage to property, caused or alleged to be caused in whole or in part by the negligent acts or omissions of the Releasees or otherwise to the fullest extent permitted by law.
